
Anti-Ragging Committee

1. The member of committee will observe the overall behavior of student in and outside the campus apprehend culprits.
2. It shall record all verbal /telephonic/written complaints and take action as stipulated in the bye-laws of the institute.
3. It shall keep the principal informed of all events/occurrence of ragging in the college.
4. Anti-ragging committee will assisted by member of college teaching staff detailed by the office of the principal on day to day basis to keep vigil on on toward events.

What constitutes Ragging?

Ragging constitutes one or more of any of the following acts.

1. Any conduct by any student/s whether by words spoken or written or by an act which has the effect of teasing or handling with rudeness a student/s.
2. Indulging in rowdy or indiscipline activities by any student which causes or likely to cause annoyance, hardship, psycho-physical harm or to raise fear or apprehension thereof in any other student.
3. Any act by a student/s that prevents disturbs the regular, academic activity of any other student.
4. Exploiting the academic tasks assigned to an individual or a group of students.
5. Any act of financial extortion or forceful expenditure burden put on a student by a student or a group of students.
6. Any act or abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
7. Any act or a abuse by spoken words, emails, sms on mobile, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill form actively or passively participating in the discomfiture to student/s.
8. Any act that affects the mental health and self-confidence of student/s or showing superiority or authority by student/s or bullying them.
