

OBJECTIVES:


1. To develop a responsive and accountable attitude among all the stakeholders.
2. To maintain a harmonious educational atmosphere in the institute.
3. To prohibit rowdy and in disciplined activities by students in the campus of institute.
4. To take action in accordance with rules and regulations as stated by college / institute / AICTE ,as well as under the provisions of any penal law of the time being in force against those found guilty of ragging and / or abetting ragging, actively or passively, or being a part of conspiracy to promote ragging.

The following instructions are framed to prevent the menace of ragging and foster healthy interpersonal relations among students in the campus of K.P. Patil Institute of Technology (Polytechnic), Mudal.

STUDENTS:

1. **Ragging is strictly forbidden** in or outside the campus of our institute.
2. All the students shall familiarize themselves with **rules / regulations / guidelines on code of conduct, anti-ragging measures and discipline** of our Institute.
3. All students should attend counseling sessions organized for them from time by the college staff.
4. Students can approach the chairman or any committee member for personal / academic counseling
5. Any student who suffers ragging or notices occurrence of ragging shall immediately report the event to concerned authority.
6. Incidences of ragging can be reported to any member of Anti-ragging committee in the college.
7. Students may report incidence of ragging either orally or in writing. They may also report the incidence in person. Anonymity of the student will be maintained.
8. Any victim of ragging not satisfied with the action taken by the committee or the Head of the Institution may submit an appeal in writing to report the event to the local police.
